Buyers will have 14 days to remove all their small purchases; after this date, all remaining items are subject to forfeiture. Buyers of larger items will be required to contract for removal within 7 days of the auction. Removal deadlines will vary by lot. The equipment belongs to Badger State Ethanol, which operates a grain processing facility that produces 90 million gallons per year of ethanol along with co-products of carbon dioxide, corn oil and animal feed/heating pellets. The feedstock for the pelletizing plant came from the production of ethanol. The remaining DDGS was then either processed into pellets and/or sold in bulk to local consumers. The pelletizing and other surplus equipment is being auctioned due to the plant's expansion and optimization going from 40 to 60 to now 90 million gallons per year of ethanol production.
